

**AGREEMENT  
BETWEEN THE MINISTRY OF TRANSPORT OF THE RUSSIAN FEDERATION  
AND THE MINISTRY OF TRANSPORT AND COMMUNICATIONS OF THE REPUBLIC  
OF ARMENIA  
ROAD TRANSPORT**

**(Moscow, September 8, 1992)**

The Ministry of Transport of the Russian Federation and the Ministry of Transport and Communications of the Republic of Armenia, hereinafter referred to as "the Contracting Parties", in accordance with the Agreement between the Government of the Russian Federation and the Government of the Republic of Armenia on the principles of cooperation and mutual relations in terms of transport,

Desiring to further the development of road links between the two countries and in transit through the territory of the Russian Federation and the Republic of Armenia,

Have agreed as follows:

Article 1

This Agreement defines the terms passage of motor vehicles (buses, trucks, trailers and semi-trailers with or without) the carriage of passengers and goods between the two countries and in transit through their territories, as well as the mutual coordination of activities related to the development and operation of road transport.

Article 2

Each Contracting Party shall provide the conditions for the free movement of vehicles of the other Contracting Party in the territory of the state, including those in transit to third countries.

Article 3

When the traffic on the basis of this Agreement, carriers of one of the Contracting Parties, in the territory of the Russian Federation, respectively, and the Republic of Armenia, there is required to observe the traffic rules, laws and regulations relating to road transport.

Article 4

1. The Contracting Parties have agreed to maintain the current at the time of signing the rules, directions, regulations, guidelines, standards and specifications governing the road transport.

2. Change, as well as approval of new regulations affecting the interests of the other Party shall be made by mutual agreement between the Contracting Parties.

Article 5

The Contracting Parties shall in the territories of the states equal conditions of transport and transport - forwarding enterprises, regardless of ownership and belonging to the states - participants of this Agreement, the sale of transportation and freight forwarding services, as well as contribute to the creation of joint ventures, including on equity basis.

Article 6

Contracting Party on the basis of reciprocity, will coordinate work in the field:  
science and technology policy in road transport;  
drafting laws and regulations, standards, and regulations governing the operation of motor transport;  
creating the conditions for the provision of technical assistance to the rolling stock, vehicle refueling with fuels and lubricants;  
assistance in case of accidents.

#### Article 7

Each Contracting Party shall recognize in its territory issued by the competent authorities of the Russian Federation and the Republic of Armenia registration documents and license plates on vehicles, as well as proof of qualifications for the right to control a motor vehicle.

#### Article 8

The Contracting Parties shall settle all disputes relating to the interpretation or application of this Agreement through negotiations and consultations.

#### Article 9

This Agreement shall enter into force upon signature and shall remain in force until the expiration of 90 days from the date on which one of the Contracting Parties notify the other Party in writing of its intention to terminate the Agreement.

Done in Moscow on September 8, 1992 in two originals, each in the Russian and Armenian languages, both texts being equally authentic.
